NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that the aforesaid Master Deed is amended as follows:

Article X, Section 10.7 of the Master Deed is amended so that, as amended, Article X, Section 10.7 shall read as follows:

10.7 Grills

The use of individual grills (charcoal, gas or electric) is a fire hazard and is strictly prohibited within five feet (5') of the Building. Provided that an Owner uses the grill five feet (5') or more from the Building, an Owner may use a grill in accordance with any Rules or Regulations specifically adopted therefore, the City of North Myrtle Beach Fire Code from time to time existing, and within the Limited Common Area patio of such Owner's unit further described in Section 3.4(e)(i).

Any other provisions in the Master Deed or the By-Laws for the Association which are otherwise inconsistent with this Amendment are hereby amended so that such provisions are consistent with this Amendment. All other provisions of the aforesaid Master Deed and By-Laws shall remain unchanged.
